### 7f. Equipment Officer:

There has been no activity with P-hanger anchors in the last two years due to the lak of a training course. Finally however a P-hanger Installer & Maintenance Course has been run and financed and financed by the BCA. There are now 4 Qualified Installer & Maintainers (Dave Ludlam, Andy Lewington, Steve Tomolin & Dave Appeling). Work across the region is being co-ordinated by DL and records are centralised with CCC. At present anchors are in god shape. A few anchors in Pwll Dwfn are due for a standard test. The BCA have generously said they will provide a portable anchor tester to each region.

### 8f. Dan yr Ogof C.A.C.:

Lots of work has been done sorting out the fixed aids. This is to allow progress beyond The Rising using SRT. Fishermen on the Tawe (downstream of the resurgence) have complained about the red colour of the water coming out of the cave. This has been identified by cavers as a natural phenomenon caused by a natural sediment colouring the water after rainfall. Research is ongoing to explain this phenomenon.

# 8j. FODCCAG: report by MF

Permit system with Forestry Commission (FC) is working OK despite still some un-authorised caving activities.

Work for FC / English Nature (EN): grilling work at a number of cave and mine sites at the request of FC. One site has otter activity hence discussion with EN, EA & FC.

Bats: 5 cSACs now upgraded to SAC status. Base line bat monitoring programme carried out in 2005 for EN / FC etc. – local cavers heavily involved inall aspects of this project along with some members of G.B.G. Next phase is continued monitoring using same criteria as 2005. Using EN/FC/FODDCAG Bat monitoring protocol. Radon project ongoing.

BCA/BCT/EN liaison meetings ongoing.

JH reported that Cwm Ysthwyth Mine appears to now have grilled entrances.

# 10. CCC Spending Projects 2006-7:

GCRG: PT reported that GCRG had supprted WBCRT in OFD rescue in May – a god team effort which is important for a big rescue. The recent Miss Graces Lane joint rescue practice was very successful. Run as a series of workshops with different casualties.

NWCRO: PN reported that insurance was prohibitively expensive - £670 this year to insure £5000 of gear. Min insurance cover £20K. Insurance needed for grant applications but often grants not worth much more than cost of insurance.

### 13. AOB:

PT – a film has been made by a commercial organisation in the Forest without permission from FE or FODDCAG – sort of cavalier attitude to access that could have negative effect on access. New edition of guidebook to Caves in the Forest of Dean – copies available from PT. JH also publicised book "Water Power in Mining: Mining History" – copies from him.
