## THE CCC AGM

- Formation of British Caving Association continues and the AGM supported it's progression. CCC AGM

  a vote.

  agreement with Forest Enterprise has provided benefits to both cavers and FE.

- Four caving foreign expeditions are to receive funding from Sports Council for Wales
